## Key information

### 1. How do we determine eligibility of the article for the Spanish agreement?

- The acceptance date of the article should be on or after 1st January 2021
- The corresponding author must be affiliated with the participating Spanish institution or a faculty/department
- The article must be from an eligible journal

### **2. As a Spanish corresponding author, what is the discount I receive when publishing in Elsevier journals**

- You receive full Article Publishing Charge (APC) coverage when publishing in Hybrid journals
- You receive 10% discount on the APC when publishing in Gold OA journals

## Key information

### 3. Role of the institutional librarian in the Elsevier OA Platform (EOAP)

- By the time the article in is your EOAP, we have published the first version of the article in ScienceDirect (within 48 hours of acceptance)
- The librarian therefore is not approving the publication of the article, but is validating whether the corresponding author can make use of the APC funds/discount as part of the agreement

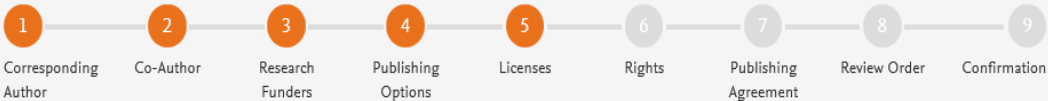

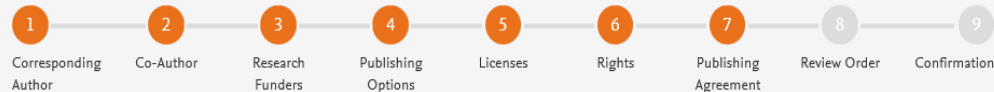

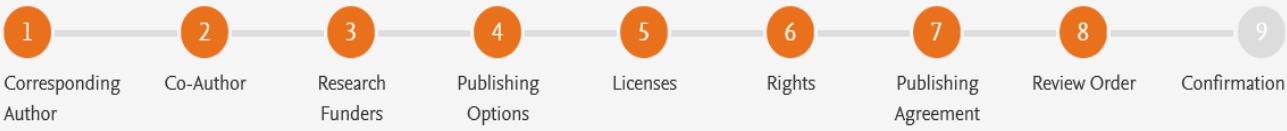
