

ERASMUS+ KA171 CALL OF MARCH 8, 2024 OF THE VICE-RECTORATE FOR INTERNATIONALISATION AND GLOBAL ENGAGEMENT OF THE UNIVERSITY OF CANTABRIA FOR INCOMING EXCHANGE STUDENTS IN THE FRAMEWORK OF THE 2022-1-ES01-KA171-HED-000073368 AND 2023-1-ES01-KA171-HED-000122364 PROJECTS

1. OBJECTIVES

The Vice-rectorate for Internationalisation and Global Engagement of the University of Cantabria offers **39 Erasmus+ mobility grants for incoming exchange students** for the academic years **2023-2024 and 2024-2025** (check Anex I for study level) within the framework of the Erasmus+ International Credit Mobility project 2022-1-ES01-KA171-HED-000073368 (budget application 02.73.00.ZC22-ZC28.422D.22690) and project 2023-1-ES01-KA171-HED-000122364 (budget application and 02.73.00.(ZD15-ZD24)-422D-226.90). This call complies with the guidelines established by the Erasmus+ Programme and by the Spanish Service for the Internationalisation of Education (SEPIE).

These grants allocated will be distributed among the following partner universities according to the existing Inter-institutional Agreements with the University of Cantabria:

- African University of Science and Technology
- Ecole Nationale d'Ingénieurs de Sfax
- Indian Institute of Technology Madras
- Institute of Economy and Trade of Tajik State Univ. of Commerce
- Sami Shamoon College of Engineering
- Tanta University
- Tashkent Chemical-Technological Institute (TCTI)
- Universidad Cooperativa de Colombia
- Universidade de Cabo Verde
- Université de Tunis Tunis Business School (TBS)

The aim of the mobility grants is to fund a mobility exchange period at the University of Cantabria for which academic recognition will be obtained. After their mobility period, they will return to their sending institution to complete their studies and get academic recognition of those courses successfully passed at the University of Cantabria. **Partner universities will ensure recognition for successfully completed courses of the mobility students.**

2. GENERAL ADMISSION REQUIREMENTS

- To be enrolled in an official degree of higher education in any of the universities participating in this call during the current academic year 2023/2024 as well as during the academic year when the mobility period takes place.
- To have previously **completed the equivalent of two years of university studies** (applicable to bachelor students).
- To fulfill the academic requirements of the existing Inter-institutional Agreements and Annex I of this call.
- To fulfill the specific requirements of the Erasmus+ Programme.
- It is highly recommended to accredit a B1 level of Spanish to register and follow regular courses in Spanish and a B2 level of English to register and follow courses taught in English. In case the applicant cannot prove these language requirements by means of an

official language certificate, the application could be discarded by the UC. Accreditation of higher levels will be assessed positively.

3. DESCRIPTION AND DURATION OF ACTIVITIES

Students attending regular courses must stay for a whole academic semester at the receiving institution so as to be able to attend classes and exams. The duration of the stay of Master and PhD students preparing their thesis will require to be previously agreed with both the academic coordinator at the home and at the host university.

3.1. Duration

Minimum 2 and preferably 5 months maximum. Mobilities must be finished by **July 18, 2025 at the latest.**

4. GRANTS

The participants will obtain a grant for travel costs and for individual support. The amount of grants offered may not cover all the possible expenses, but are considered as a contribution to bearing the additional costs of staying abroad. In case that the amount is insufficient to cover all costs, the students will need to find other funding sources.

4.1. Travel costs contribution (one round trip plane ticket)

Flight tickets will preferably be purchased by the University of Cantabria for all mobility participants according to the program regulations, based on the Erasmus+ distance calculator maximum fees:

4.2. Individual support

Selected participants will receive a monthly allowance under this call that amounts to 850 €/ month. The total amount will be calculated on the basis of the number of days. The total payment of the grant goes as follows:

- 70% of the total amount of the grant will be paid to the participant upon arrival at UC.
- 30% of the total amount of the grant will be paid by the end of the exchange period, once the participant has completed the Erasmus+ online survey. However, this last payment is

considered as a **balance payment**, thus possible adjustments could be made in case of a variation in the duration of the Erasmus+ stay initially approved.

Students obtaining this Erasmus+ grant are entitled to keep any other national grant in their home country.

4.3. Individual support for participants with fewer opportunities

Participants with fewer opportunities will receive an extra grant of 250 €/month. The disadvantage situation must be indicated in the application together with the corresponding accredited documentation. In the selection process, preference shall be given to participants with fewer opportunities.

4.4. Academic fees

No academic fees for regular courses will be charged at the University of Cantabria to the mobility participants.

4.5. Participants

Participants may not accept during the exchange period any other mobility grant awarded by the European Union.

4.6. The University of Cantabria has the right to suspend the payment of the grants if:

- Participants withdraw from the project.
- Participants do not comply with the regulations of both the partner institution or the University of Cantabria.
- Participants do not fulfil the requirements of the Erasmus+ Programme.

5. APPLICATION PERIOD

• March 11 to 31, 2024.

Should not all mobility grants be awarded after the application period, the University of Cantabria reserves the right to open a new application period for the remaining grants that will be duly disseminated among partner universities.

6. APPLICATION PROCEDURE

Applications must be centralized and submitted through the corresponding contact person in each partner institution (see Annex III).

In order to apply for the grant, candidates shall follow the following steps:

- Check the eligibility criteria so as to ensure that applications requirements are met.
- Check the distribution of grants and priority disciplines by countries and universities.
- Check the academic offer of the University of Cantabria:

- Check the information concerning the documents to be submitted (as listed in Annex II to this call) when applying for the grant. Please note that all the required documents must be translated in Spanish or English and scanned and sent to the contact person of the partner university.

7. SELECTION PROCEDURE AND CRITERIA

Once the period for submission of applications has concluded, partner universities shall conduct a check to ensure that candidates and documents meet the formal requirements and have been submitted in full before proceeding to validate candidates. Those candidates who are validated will be eligible for the selection process.

During the first stage of the selection process, partner universities will assess the applications of the students enrolled in their institution. The evaluation will be made according to the following criteria:

- Academic performance: (from 0 to 50)
- Knowledge of teaching language: (from 0 to 20)
- Relevance of the proposal: (from 0 to 20)
- Socio-economic background: (from 0 to 10)

A weight of 60% will be assigned to the assessment of the partner HEI and 40% to the UC. Both scores will be added to obtain the final scores.

On equal terms, priority will be given to applicants who have never participated in the Erasmus programme before or who can prove a higher level of language skills.

Partner universities will rank evaluated candidates by total score in a nomination list and will include in every case the status 'selected', 'waiting list' or in case there are not enough grants offered for all the evaluated candidates 'not selected' if the applicant does not meet the requirements.

The Internationalisation Committee of the University of Cantabria will validate the selection results sent by partner institutions and will proceed to issue the final nomination list. All procedures will be carried out according to ECHE commitments.

8. LIST OF SELECTED PARTICIPANTS

The list of selected participants will be published at the Erasmus+ KA171 International Credit Mobility website of University of Cantabria and **partner universities will be required to publish them in their own websites.**

Participants are entitled to appeal in the five natural days after the publication of results. After the appeal period, a new list of final participants will be published should there be any variations.

9. OBLIGATIONS OF THE PARTNER INSTITUTION / UNIVERSITY OF CANTABRIA

9.1. Partner Institution

- The partner university will collaborate with the UC in the correct implementation of the project, providing relevant documentation and monitoring participants in all phases of the exchange.
- The partner institution commits to recognize the studies included in the Learning Agreement counting towards the degree and/or to recognize the academic activity carried out at the University of Cantabria.
- The partner's institution selection committee must submit a document stating the Absence of Conflict of Interest.
- After the mobility, **the partner institution is to send a copy of the student's transcript of records/academic recognition**, once the academic results have been transferred.

9.2. University of Cantabria

The University of Cantabria is responsible for paying to the participants their individual support and to reimburse/purchase their expenses associated to travel costs by the quickest and most adequate means allowed by its Financial Service.

10. OBLIGATIONS OF THE PARTICIPANTS

- **10.1.** Participants must provide all documents required by the University of Cantabria in due time to its International Relations Office:
 - A copy of the visa
 - A copy of an insurance policy covering medical costs, accidents, and repatriation.
 - The Erasmus+ Grant Agreement issued by the International Relations Office of the UC signed.
 - Their travel costs documents (boarding cards, bus tickets or train tickets) upon arrival at the UC.
- **10.2.** Participants have to complete all the administrative, academic and report requirements of the University of Cantabria and the Erasmus+ program before, during and after their mobility:
 - Have the obligation to inform the University of Cantabria about any change regarding the study period abroad, namely in the study plan (by submitting the `during the mobility' section of the Learning Agreement duly completed), or in the duration of the stay by informing at least one month before the end of the mobility.
 - Have the obligation to attend their classes/labs regularly in the UC, except in cases of force majeure.
- **10.3.** At the end of the mobility, the participant will have:
 - To **submit the online Participant report** addressed by the Erasmus+ Programme before his/her departure from the University of Cantabria. The University of Cantabria is entitled to partly or totally ask to return the Erasmus+ grant if this requirement is not properly and timely filled.
 - To send to the International Relations Office of the UC his/her **travel costs documents** (boarding cards, bus tickets or train tickets) corresponding to the **return trip.**
 - To submit the **Recognition Report** addressed by the Erasmus+ Programme after his/her departure.

• To obtain his/her **UC Transcript of Records by downloading it** from the online *Campus Virtual UC* and submit a copy to the contact person in the partner institution.

11. DATA PROTECTION

Personal data shall be processed in compliance with adherence to the stipulations set out under (EU) regulation 2076/679 of the European Parliament and Council, of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/CE (General Data Protection Regulation) and Organic Law 3/2078, of 5 December, on the Protection of Personal Data and guaranteeing of digital rights.
