3.1 RESULTADOS DE APRENDIZAJE

- Los adquieren una visión general de la economía de los servicios públicos mediante el análisis del funcionamiento de los mercados, las empresas y las regulaciones de infraestructura de energía, telecomunicaciones y agua.

Los alumnos aprenderán a preparar un caso de estudio similar a los realizados para organizaciones internacionales (OCDE, EU EC), realizar presentaciones en público a partir de la bibliografía y los datos seleccionados.

Se familiarizarán en la manipulación de bases de datos sobre regulación de servicios públicos (OECD REFREG), privatización de distintos sectores y países (PRIVATIZATION BAROMETER), preferencias declaradas en la UE y América Latina (EUROBAROMETER), preferencias reveladas (EUROSTAT HBS).

4. OBJETIVOS

This course examines the long-term transformation and reform of public services, including privatization, liberalization, deregulation, New Public Management and, finally, internationalization. We adopt a European and an international perspective.

Economic, institutional, technological, social and political aspects of the way in which public services have been organised will be analysed, and how they have been financed, particularly in the European Union and Latin America.

The sessions will focus on public services operating in networks: communications, energy, transportation, water and other infrastructures. Innovations and alternative public policy affecting these services will be examined.

A través del desarrollo de este programa se examina desde una perspectiva internacional las transformaciones y las reformas de los servicios públicos, como la desregulación, la privatización, la internacionalización, (re)regulación supranacional mediante obligaciones de servicios de interés general y la introducción de nuevos criterios de gestión pública de servicios e infraestructuras de servicios. A su vez, se revisan los principales fundamentos económicos, institucionales, políticos y sociales de su organización, los patrones de provisión y financiación de los servicios públicos, en particular, en el marco de la Unión Europea, pero también en otras regiones y países como América Latina y Asia. En el curso se analizan diversos casos de servicios públicos, como los operados en base a redes e infraestructuras: comunicaciones, energía, transportes, agua e infraestructuras, y se explorará y evaluarán las innovaciones y las alternativas de políticas públicas que se pueden extender a otros servicios sociales.
