### Observations

In case of not passing the subject with this evaluation method, the students will be able to take the final test on the date set at the beginning of the course by the Master's Directorate, which with a total estimated duration of 4 hours, is structured as follows shape:

-Final exam on the contents of the subject with a battery of questions and practical assumptions with a percentage of the qualification of 60%

-Preparation, presentation and defense of 15 minutes of a work on the teaching specialty of professional training that the student chooses with a percentage on the qualification of 40%
