- Students are expected to acquire a general knowledge of the History of Ancient Rome, getting familiar with different types of documents and their specificities and with current trends of research in the field. They also must learn the basic tools for researching in Roman History and be able to express themselves orally and in writing with the language of the discipline.

4. OBJECTIVES

It is intended that students get an overview of the evolution of the history of Rome from its origins until the fall of the Empire, with special emphasis on the political, social and religious aspects. They also may get familiar with the ancient sources through reading and commentary on historical documents of various kinds, as well as to know recent historiographical trends and methods in the field.

Observations

In order to pass the course, students must attend at least 80% of lectures. An absent of more of this percentage must be duly justified.
