Identify, based on its own characteristics, the historical phases of Spanish constitutionalism.

Know how to adequately identify the essential features of the Spanish Constitutional Preamble, as well as conceptually understand the meaning of the essential values ??of the legal system, and correctly describe the content and projection of the structural principles that make up the definition of the Spanish State.

Understand in an individualized and interrelated way the sources of Law of the state legal system, the specific ones of the subordinations of the Autonomous Communities, the function and structural position of the International Treaties, of the Law of the European Union, and the relationships between the legal system "community" and the "internal" order.

Observations
